Specifically, BCMB, BIOL, CBIO, GENE, or MIBO majors must submit a final paper meeting the requirements for the equivalent course number (for example: a biochemistry major seeking credit towards a BCMB 4960R requirement would register for IDIS 4960R and write the final paper using the criteria indicated for BCMB 4960R). The final paper should be turned in to the student's major office and the IDIS office via email by the appropriate deadlines. The final paper for students for any other major must meet the requirements for an IDIS 4960R-4980R research paper (these requirements can be found on the IDIS Undergraduate Research website). The final paper must constitute a minimum of 25% of the course grade, regardless of major.

Access is granted **after** a student's application is approved by IDIS. Submit your application to room 3581 in the College of Veterinary Medicine or email to jenley11@uga.edu. Enter through one of the entrances on D.W. Brooks Drive, turn left, proceed down the hallway past the student lobby to the elevator.
